## **Circular From West Park Residents Association**

### ***Connecting Leeds - Lawnswood Roundabout***

The first phase of the A660 Connecting Leeds consultation has now been completed, with plenty of comments coming from residents. The next stage is likely to involve small group discussions with those residents especially affected by proposals such as Otley Old Road and West Park Ring Road. Both of these involve the loss of grass verges plus significant changes to the Lawnswood junction, which is currently an attractively-planted roundabout.

After the small group meetings there will be larger public meetings to show the revised proposals and they will be publicised in early September.
